Dark Elegy Remembering the Moment: Terrorism's Legacy

As you may recall from previous correspondence late last year, supporters of a very moving piece of sculpture depicting figures of woman mourning the loss of loved ones and ultimately represents victims of terrorism everywhere, have pushed for the sculpture (collectively named Dark Elegy) to be placed on government land to serve as a public memorial to victims of terrorism all over the world.

As a result of concerted efforts on and off the Hill, Congressman Tim Bishop (NY-1) has introduced legislation on behalf of Dark Elegy. This legislation would grant Dark Elegy the designation it needs from the government to be placed on government land and serve as a public memorial to victims of terrorism, everywhere.

Now, a public hearing has been scheduled for this legislation (HR 3707) in order for those close to Dark Elegy and victims of terrorism to provide oral testimony, written testimony or public support in the form of presence in front of the National Capital Memorial Advisory Commission (NCMAC). This is necessary because the Commission will be voting on their support or opposition to the legislation. We need for them to have favorable testimony in hand so we can advance the legislation further and take another step closer to recognizing the goal of making Dark Elegy a public memorial in Washington DC.

If you would like to provide testimony and or be a speaker at the hearing, scheduled for **Tuesday, February 26 at 1:30pm**, we are looking for you! We are looking for statements from those impacted by not only Pan Am 103 but also by other terrorist attacks.

The deadlines are as follows: Friday, February 22 (to get it distributed to Commission members at the public hearing) or by March 7 th (last day to submit public testimony following the public hearing).
